

### YOUR ITINERARY

## Days 1/2/3~Sunday/Monday/Tuesday~ November 2/3/4 USA/Bangkok

Your exciting Asian adventure begins as you fly to Bangkok where you will be welcomed by your Classic Escapes representative and escorted to your airport hotel. You will have time to freshen up, relax and get a good night's sleep.

Novotel Suvarnabhumi Airport Hotel is only a five-minute walk through a 985-foot underground walkway from Bangkok's new airport. Suvarnabhumi International Airport is located in Racha Thewa in Bangphli district, Samut Prakan Province, about 19 miles east of central Bangkok. The elegant and luxurious hotel features 612 rooms, five restaurants, two bars, an outdoor swimming pool, fitness centre and health spa. Free Wi-Fi.

### Day 4~Wednesday~ November 5 Bangkok/Paro, Bhutan/Thimphu

Return to the airport for your flight to Paro where upon arrival, you will be met and escorted you to the hotel in Thimphu, the modern capital town of Bhutan. The drive takes you through the winding road with lots of beautiful hamlets. Upon reaching Thimphu, check-in at your home for the next two nights, Hotel Druk.



Enjoy lunch at the hotel and then drive to the Royal Textile Academy. Weaving is an integral part of the culture and tradition of Bhutan. With the aim to conserve, restore, and document this living art, the Royal Textile Academy of Bhutan was set up by the queen mother, Her Majesty Ashi Sangay Choden Wangchuck as a non-government, non-profit, organization. Inaugurated in 2001, the academy is also a national centre for educating young students in textiles, fabric



design and museum studies. It serves as a centre for tourists, introducing the nation's masterpieces to its visitors, while preserving Bhutan's weaving traditions.

Next, visit the National Institute offering courses on the 13 traditional arts and crafts of Bhutan, all ranging between four to six intensive years of training. Zorig Chusum plays an important role in the 'Preservation and Promotion of Bhutan's Cultural Heritage', which is one of the four main pillars of the Gross National Happiness philosophy, which Bhutan is globally renowned for. In addition to learning an array of art forms, such as painting, stitching, and carving, it is fascinating to witness the skill and discipline imbibed in the institute's students as well as the spectacular art they create.

Last for the day is at the Jungshi Paper Factory, perched high on a hillside overlooking the Thimphu valley, about ½ a mile away from Thimphu city. The factory makes high quality handmade paper using the bark of the Daphne and Dhekap tree. A variety of styles are made with beautiful textures and prints using pressed flowers and leaves. This kind of paper, called Deh-sho, was originally used in monasteries for manuscript and prayer books.

Built in 1974, Hotel Druk was one of Bhutan's original guest hotels, located close to Clock Tower Square and Memorial Chorten in walking distance

from many shops and markets. All 51 individually furnished rooms have recently been renovated, and feature comforts such as fireplaces and heated floors, and air conditioning. Bathrooms have rainfall showers, shower/tub combinations, and free toiletries. There's a restaurant and a spa, plus a gym, a conference hall and a bar. Free in room Wi-Fi access.


Start your day with a visit to a massive golden Buddha sitting atop a hill in Thimphu. Meaning Vajra-throned Buddha, the gigantic Shakyamuni Buddha statue, filled with 125,000 smaller Buddha statues, each like the Buddha Dordenma itself, is made of bronze and gilded in gold. At a height of 169 feet, it is one of the tallest Buddha statues in the world. The statue itself symbolizes Bhutan's commitment to promoting peace and spiritual wellbeing, and it represents the essence of Buddhism in Bhutan.

Hike on a trail that will take you through a beautiful forest patch towards



Changangkha Lhakhang. The hike provides magnificent views of the Thimphu valley below. This trail is often used by His Majesty the fourth king as his mountain biking trail.

You will stop for lunch at a local restaurant.



Continue your drive to the National Memorial Chorten, a well-known landmark in Thimphu, built in 1974 in the memory of the third King, Jigme Dorji Wangchuck who is popularly regarded as Father of Modern Bhutan. This four-story structure was built to be seen as the most visible religious landmark in the Dragon Kingdom. It serves as an important place of worship for Thimphu residents, as well as devotees from other parts of the country. Within are carvings of mandalas, statues, and religious teachings.

Next, stop is at the Royal Takin Preserve, a wildlife reserve area for Bhutan takin, the national animal of Bhutan, located just 10 minutes away from Thimphu city. This large, shaggy and hoofed mammal has a bit of mythology tied to it. Legend has it that the animal was created by the great Buddhist yogi, Drupa Kunley or 'the Divine Madman'. This particular species of takin is found only in Bhutan and western Arunachal Pradesh. Originally a zoo, the fourth king decided to disband it since keeping animals in cages did not align with Bhutan's environmental and religious beliefs. The animals were released into the wild, however the takin was too tame to survive, and wandered around the streets of Thimphu. This led to the making of the Royal Takin Preserve. Now the animals are kept in a large enclosure where visitors can observe them.




Embark on a multi-sensory experience as you pass the vibrant stalls of Thimphu's Farmer market, where most of Thimphu's population and many valley dwellers converge on the bustling market. A wide range of foodstuffs and local arts and crafts are sold at the market. Towards the evening, stroll through the Craft bazaar. Overnight at the HOTEL DRUK, THIMPHU. (B,L,D)

### Day 6~ Friday~ November 7 Thimphu/Paro

After breakfast, drive back to Paro, a historic town situated at 7,382 feet, with many sacred sites and historical buildings scattered through the area. It is home to many of Bhutan's oldest temples and monasteries, the National Museum and the country's only airport. Mt Jhomolhari (24,035 ft) reigns in its white glory at the northern end of the valley. Its roaring glacial water plunges through deep gorges to form the Pa Chu (Paro River). Paro is one of the most fertile valleys in the Kingdom, producing a bulk of the locally famous red rice from its terraced fields.

Continue with your visit to the National Museum of Bhutan housed inside the revamped circular Ta-dzong building, an ancient watchtower above the Paro Dzong. This unusual round building is said to be in the shape of a conch shell. The original building was constructed in 1656 but the building was converted into a museum in 1968. The necessary infrastructure was created to house some of the finest specimens of Bhutanese art, including masterpieces of bronze statues and paintings gathered from different parts of the country. The museum has 13 galleries covering Bhutanese Buddhism, ceremonial scroll paintings, prehistoric and religious items, arms and armor, natural history and crafts.





Upon arrival, drive straight to visit Ta Dzong; a watch tower built to defend Rinpung Dzong during the intervalley wars of the 17th century. Since 1967, the Ta Dzong has been serving as the National Museum of the country. It holds a fascinating collection of art, relics, religious thangka paintings, natural history, and Bhutan's exquisite postage stamps. The building's circular shape comes from its defensive origin.

Continue to Paro Dzong, one of the most impressive and well-known dzongs in Bhutan. One of the finest examples of Bhutanese architecture, it is also known as the Ringpung Dzong, which means 'fortress on a heap of jewels. The dzong was built in the 16th century on the foundation of a monastery built by Guru Rinpoche, who



arrived here on the back of a tigress during his crusade from Tibet to Bhutan more than a millennium ago. It was used on numerous occasions to defend the Paro Valley from invasions by Tibet. The Dzong was not destroyed in the massive 1897 earthquake, but it was almost burnt to the ground by a fire in 1907 and was rebuilt the following year.

Check-in and have lunch at the hotel. After lunch, you will drive to visit the Kyichu Lhakhang which is one of Bhutan's oldest and most beautiful temples. The main chapel has roots as far back as the 7th century. Legend has it that an ancient king built 108 temples in a single day to pin down a vile demoness; these temples span from Bhutan to most of eastern Tibet. Out of the 108, two lie in Bhutan, and Kyichu Lhakhang is said to hold down the left foot of the demoness. The central figure of the temple is a large statue of a Sakyamuni Buddha.


Afterwards, pay a visit to a local Farmhouse. The beauty of Paro valley is embellished by clusters of old-fashioned farmhouses. Bhutanese farmhouses are very colourful, decorative and traditionally built without the use of a single nail. All houses follow the

same architectural pattern. A visit to a traditional farmhouse is educational and offers a glimpse into the lifestyle of a

farmer.

Your luxurious hotel is situated on the edge of the Paro River, offering panoramic views of the Eastern Himalayas. All 59 individually furnished rooms are equipped with modern amenities. Contemporary marble bathrooms come with a glass-enclosed rainforest shower and separate soaking bathtub with designer toiletries. The hotel's two restaurants, Bamboo Chic and Latest Recipe and Latitude bar offer dinners and exquisite seasonal experiences. Treat yourself to a body treatment, reflexology, or a body scrub at Le Meridien Paro, the onsite spa. Free in-room Wi-Fi.



## DAY 7~ SATURDAY~ NOVEMBER 8 PARO~ HIKE TO TAKTSANG

After an early breakfast, take a hike to Taktsang Monastery, the unofficial symbol of Bhutan, popularly known as "Tiger's Nest" perched on the side of a vertical cliff at 9,842 feet. Legend has it that Guru Rinpoche (Guru Padmasambhava) flew to this location from Khenpajong, Tibet on the back of a tigress and subdued a demon. He then meditated in a cave here for three years, three months, three weeks, and three hours way back in the 700's and emerged in eight incarnated forms (manifestations) and blessed the place. Guru Padmasambhava is known for introducing Buddhism to Bhutan. Today, Paro Taktsang is the best known of the thirteen caves in which he meditated. The hike (4-5 hours) is "moderately difficult" meaning hard for people who rarely hike, but not so tough for experienced hikers in decent physical condition. The Tiger's Nest is indeed everything people say it is – a destination worthy of any "bucket list."



A picnic lunch will be organized at the base of the Taktsang.

The rest of the afternoon is at leisure to relax, or if energy permits, explore Paro town to shop for souvenirs. Overnight at LE MERIDIEN. (B, picnic L,D)

## Day 8~ Sunday~ November 9 Paro/Kathmandu

Today return to Paro airport to board your flight to Kathmandu, the capital and largest urban agglomerate of Nepal. The agglomerate consists of Kathmandu Metropolitan City at its core and its sister cities Patan, Kirtipur, Thimi, and Bhaktapur. The city stands at an elevation of approximately 4,600 ft in the bowl-shaped Kathmandu Valley of central Nepal. It is surrounded by four major mountains: Shivapuri, Phulchoki, Nagarjun and Chandragiri.



Upon arrival at the Kathmandu Tribhuwan International, you will be met and escorted to your hotel.


Dusit Princess Katmandu located in Lazimpat, beautifully combines Nepalese traditions with Thai hospitality. All 107rooms boast comforts such as laptop-friendly workspaces, LED TVs with digital channels, hypo allergenic bedding and air conditioning, as well as bathrooms with free toiletries and hair dryers. The hotel has the city's highest infinity pool, and state-of-the-art fitness facilities. Guests can visit the spa to indulge in Thai massages or aromatherapy. ## Day 9~Monday~ November 10 Kathmandu

After breakfast, enjoy a visit to Kathmandu Durbar Square, a complex of palaces, courtyards and temples, built between the 12th and 18th centuries, it used to be the seat of ancient Malla Kings of Kathmandu. It is the place where kings of Nepal are crowned, and their coronations solemnized. An intriguing piece here is the 17th century stone inscription set into the wall of the palace with writings in 15 languages. Probably the most famous building here is the Kumari Bahal, richly decorated with beautiful woodcarvings, which is home to the Royal Kumari, the Living Goddess, and a manifestation of the great goddess Durga. Nearby is the former Royal Palace, is a Mall Dynasty dwelling, once considerably more extensive than today. Within the courtyard of Nassal Chowk, originally hosted dramatic dance performances, and now is the coronation site of the Shah kings and contains some of the finest wood carvings you will see anywhere in the kingdom. The 14th century Jagannath Mandir is the oldest temple in the area, its steps carved with inscriptions in many languages; nearby Taleju Mandir is one of the largest and finest temples in the Valley.





Delve deep into Nepalese culture and religious history on today's tour. Swayambhunath Stupa is a UNESCO WORLD Heritage Site and one of the most sacred Buddhist shrines of Nepal. The area surrounding the stupa is filled with smaller temples, painted images and numerous statues of Tantric and shamanistic deities. Swayambhunath Stupa is one of the crowning glories of Kathmandu Valley architecture and the most ancient and enigmatic of the Valley's holy shrines; its goldenspired stupa tops a wooded hillock. Records of its history date as far as the 5th century, but its origins are believed to be older. It is the Kathmandu Valley's most sacred Buddhist shrine and while its worshippers include the Vajrayana Buddhists of northern Nepal and Tibet, Newari Buddhists are the most fervent devotees.

This afternoon visit to the US Embassy.

### Day 10~ Tuesday~ November 11 Kathmandu/Pokhara

Today's short flight whisks you to Pokhara, a place of remarkable natural beauty with views of the spectacular Annapurna massif.

On arrival you will be transferred to Hotel Barahi, your home for the next two nights.

Shanti Stupa in Pokhara was built by Nipponzan Myohoji monk Morioka Sonin with local supporters under the guidance of Nichidatsu

Fujii, a Buddhist monk and the founder of Nipponzan- Myohoji. Shanti is a Sanskrit word meaning peace, also widely used in the Nepali and Hindi languages and Shanti Stupa means Peace Pagoda. Shanti Stupa shrine was built as a symbol of peace. Situated at the height of 3,608 feet on the Anadu Hill, Nichidatsu Fujii laid the foundation stone along with relics of the Buddha on 12 September 1973. Nepal has two of the eighty peace pagodas in the world: Shanti Stupa in Lumbini, the birthplace of the Buddha and Shanti Stupa in Pokhara. It provides a panoramic view of the Annapurna range, Pokhara city and Fewa Lake.

Hotel Barahi boasts some stunning views of the Annapurna Himalayas, Phewa Lake as well as easy access to the thriving lake street of Pokhara. It is situated adjacent to the Phewa Lake, and close to Pokhara domestic airport. The hotel's 74 modern rooms come with a private balcony, have plenty of natural light and all are fitted with a tea/coffee maker and personal safe. Shower facilities and toiletries are in the private bathroom. The hotel features an outdoor pool, a fitness area, a spa, and Wi-Fi throughout the property.

## DAY 11~ WEDNESDAY~ NOVEMBER 12 POKHARA

Today is a full day of exploration. Enjoy an early morning excursion to Sarangkot, situated on the western side of Pokhara at an altitude of 5,248 feet. Known for its panoramic views of the Himalayan peaks, Sarangkot is considered one of the best places to view the sunrise and sunset. The main mountains you will see are Dhaulagiri (26,787 feet), Machhapuchhare (22.937 feet) and Annapurna II (26,538 feet).

Have lunch at a local restaurant (*on your own*) and continue with your afternoon tour of Pokhara City visiting Gupteswor Gupha and Brindabasini Temple.



Devi's Fall - Locally known as Pataale Chhango (*Hell's Fall*), Devi's fall (*also known as Devin's or David's*) is an awesome waterfall lying about 2 km southwest of Pokhara airport on the highway to Tansen. An interesting modern legend says that a foreigner named David was skinny dipping in the Pardi Khola (river) when the floodgates of the dam were opened, sweeping him into an underground passage beneath the fall, never to be seen again.

Gupteswor Gupha (Cave) - Gupteswor Gupha, a sacred cave, lies 2 km from Pokhara airport on the Siddhartha Highway. The entrance is right across from Devi's Fall and the cave is almost 3 km long. It has some big hall-size rooms and some passages where you have to crawl on all fours. This cave holds special value for Hindus since a phallic symbol of Lord Shiva is preserved here in the condition it was discovered. Taking pictures inside the cave is prohibited.

The Bindhyabasini Temple is the oldest temple in the city of Pokhara, the main temple is devoted to goddess Bindhyabasini, a Bhagawati who is the incarnation of Kali. There are smaller temples of goddess Saraswati, Shiva, Hanuman, Ganesha in the premises.

## Days 12/13~ Thursday/Friday~ November 13/14 Pokhara/Chitwan

Today after breakfast you are met and chauffeured to airport to connect flight for Bharatpur (Chitwan). On arrival check in at Barahi Jungle Lodge, Chitwan. You will have some time to relax and in the afternoon you will enjoy a village walking tour.



Chitwan is a UNESCO World Heritage Site situated in south central Nepal in the sub-tropical lowlands of the inner terai, a region in southern Nepal that lies south of the outer foothills of the Himalayas and the Siwalik Hills. The park is bordered by the Rapti and Narayani Rivers to the north, Parsa Wildlife Reserve to the east and Madi settlements and India border to the south. The rivers and their floodplains; as well as several lakes and pools, are the major water sources of the park. The park is home to 68 species of mammals, 544 species of birds, 56 species of herpetofauna and 126 species of fish and is renowned for its protection of One Horned Rhinoceros, Royal Bengal Tiger and Gharial Crocodile. This lush nature preserve protects dense sal forest, water marshes and grassland plains. The park also shelters numerous bird species.






On your second day here, you will have a whole day full of jungle activities including morning boat ride and afternoon jeep safari in the park.

Barahi Jungle Lodge is located on the banks of the Rapti River, in the small village of Tharus and provides a breathtaking view of the National Park from its river facing stand-alone cottages. The style and decoration offer a stunning insight into the aboriginal Tharu culture of Nepal combined with wilderness of Chitwan. The onsite restaurant ant features authentic Nepalese cuisine, the infinity pool provides a relaxing atmosphere from which you can watch the world go by, and the spa offers you the opportunity to take care of your mind, body, and soul. Rooms come equipped with private balconies with panoramic views of the river and park, air conditioning and en suite bathrooms. Besides the various jungle activities for wildlife viewing, the lodge also has a luxury wellness spa that offers ayurvedic therapies. There is a multi-cuisine restaurant with delectable food.



#### **Participants**

- Must be able to climb in and out of buses. People need to be willing to rotate seats.
- Must be able to tolerate walking tours on uneven terrain, mostly uphill, for three or four hours at a time.
- Should generally be in good health. Your trip includes considerable walking and some trekking. These conditions may pose problems to participants with particular physical issues, and you should always consult your personal physician before embarking on such an adventure.

#### General

- True adventure in travel can sometimes be accompanied by unexpected changes in conditions, itineraries, and occasionally your accommodations.
- Participants should travel with a spirit of adventure and flexibility. Remember to pack your patience and sense of humor! 

All deposits are subject to the Cancellation policy herein. Final payment is required no less than 95 days prior to departure (July 30, 2025) unless otherwise stated. Some airfares or services must be paid in full at the time of booking. Payments may be made by check or with a credit card (American Express, Visa, MasterCard, or Discover.) Conditioned on receipt of final payment in full, all final documents and air tickets will be sent to you approximately two weeks prior to departure.
